

SPLASH INTO SUMMER OFFICIAL CONTEST RULES

Sponsored by: Unison Credit Union 1616 Crooks Avenue, Kaukauna, WI 54130.

- 1. ARBITRATION AGREEMENT.** BY ENTERING OR OTHERWISE PARTICIPATING IN THE SPLASH INTO SUMMER GIVEAWAY, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES. THIS CONTRACT REQUIRES YOU TO INDEMNIFY AND RELEASE ALL CLAIMS AGAINST THE *SPLASH INTO SUMMER* GIVEAWAY ENTITIES (AS DEFINED BELOW) AND TO AGREE TO ARBITRATION WITH NO CLASS RELIEF AND A LIMITATION OF YOUR RIGHTS AND REMEDIES. ANY AND ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION WITH NO CLASS RELIEF.
- 2. ELIGIBILITY.** Unison Credit Union's ***SPLASH INTO SUMMER*** Giveaway is open only to Unison Credit Union Empowering Kids/Teens account members/joint accountholders who are in good standing; legal residents of Wisconsin; and who have at least one account holder having either a Social Security Number or Tax Identification Number. Giveaway is subject to all applicable federal, state, local laws, and regulations. Void in all other States of the United States and U.S. Territories and wherever else prohibited by law. Employees and volunteers of Unison Credit Union ("Sponsor"), its advertising partners, their respective subsidiaries, advertising/promotion agencies, each of their respective officers, directors, and agents (collectively, the "Giveaway Entities") and their immediate families (spouse, parents, dependents, children and siblings and their respective spouses) and/or those living in the same household of such employees are not eligible to participate. Sponsor reserves the right to verify eligibility qualifications of the prize winner. NO PURCHASE, PAYMENT, OR TRANSACTIONS OF ANY KIND NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.
- 3. CONTEST PERIOD.** The Giveaway begins on May 1, 2025 and ends on July 1, 2025 (the "Giveaway Entry Period"). The Sponsor's computer will be the official timekeeping device for this Giveaway. Winner will be notified on or about July 10, 2025.
- 4. HOW TO ENTER.** There are two (2) ways to enter the Giveaway.

Purchase Entry Method. LIMITED TO ONE (1) PER DAY.

 - Each open Unison Credit Union **Empowering Kids/Teens account** in good standing will automatically receive one (1) Giveaway entry per account.
 - One (1) entry will be provided for opening a qualifying **Empowering Kids/Teens account**.
 - One (1) entry will be provided for each qualifying cash or check* in-branch deposit totaling \$10 or more into an **Empowering Kids/Teens account** between May 1, 2025 and July 1, 2025.
 - One (1) entry will be provided for each NEW enrollment in Unison Credit Union's debit card program (available to those aged 14 and up). *Replacement debit cards are not eligible for an entry.*

- *NO ENTRIES are awarded for any EFT, ACH, P2P, or electronic transactions.*

**Entries from unauthorized check use, “check kiting,” or deposits made from checks that are lost, stolen, copied, fake or fraudulent are void.*

To enter without any kind of purchase/payment/transaction or obligation. LIMITED TO ONE (1) PER DAY. To receive one (1) Giveaway entry per day, a Unison Credit Union **Empowering Kids/Teens member (or parent if member is under 13)** may complete an entry form available at either Unison’s **GRAND CHUTE** branch location at 750 W Evergreen Drive, Grand Chute, WI 54913; or at Unison’s **DE PERE** branch location at 900 Main Avenue De Pere, WI 54115; during those branch’s normally posted business hours between May 1, 2025 and July 1, 2025. All in person entries received become the sole property of the Sponsor and will not be acknowledged or returned. Sponsor is not responsible for late, lost, incomplete, illegible, incorrect, damaged, or misdirected entries, all of which will be disqualified. Entrants under age 13 must have parental permission and signature on entry form for entry to be valid. **ONLY ONE ENTRY PER DAY WILL BE ACCEPTED**, even if entries are made at different branches.

- 5. SELECTING THE WINNING ENTRY.** A random drawing will be conducted on or about July 8, 2025, from all eligible entries received. Potential winner will be contacted on or about July 10, 2025. Odds of winning will depend on the total number of eligible entries received during the Giveaway Entry Period. Decisions of the Sponsor will be final and binding on all matters relating to the random drawing and all other matters regarding this Giveaway. Grand Prize will be awarded provided a sufficient number of eligible entries are received by the Giveaway Entry Period deadline date in order to conduct the random drawing. In the event that the potential winner cannot be contacted, fails to return the consent form within the required timeframe noted above, refuses the prize, or is disqualified for any reason, Sponsor will select an alternate potential winner in a random drawing from among all remaining eligible entries. No compensation will be given upon prize forfeiture.
- 6. PRIZE:** One (1) Grand Prize in the form of a Pool reservation on Sunday August 10th from 6:15pm to 8:15pm central time at City of Kaukauna Aquatic Center (worth approximately \$400) and a Unison Pool Party package worth approximately \$500 will be awarded. If it is determined that a contestant is using the contest for gambling purposes, they will be disqualified and reported to the authorities. **CAUTION: ANY ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE GIVEAWAY IS A VIOLATION OF CRIMINAL & CIVIL LAWS & SHOULD SUCH AN ATTEMPT BE MADE, UNISON CREDIT UNION RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.** Any automated and/or electronic submission of entry (including but not limited to entries made using any script, macro, bot, or Giveaway service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. If, in Unison CU's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Giveaway, or if computer virus, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Giveaway, Unison CU reserves the right at their sole discretion, to disqualify any individual who tampers with the entry process and void any entries submitted fraudulently, to modify or suspend the Giveaway, or to terminate the Giveaway and conduct a random drawing to award the prizes among all valid entries received as of the termination date.
- 9. FORCE MAJEURE.** Unison CU's failure to enforce any terms of these Official Rules shall not constitute a waiver of that or any other provision. The Sponsor will not be responsible for acts of God, dangerous weather conditions, pandemic virus, acts of terrorism, civil disturbances, work stoppage, or any other matters beyond the Sponsor's reasonable control (each a "Force Majeure" event) that may cause the cancellation or postponement of the Giveaway. In the event of termination of the Giveaway, a notice will be publicized by Sponsor and a drawing to award the Grand Prize will be conducted from among all eligible entries received prior to termination.
- 10. CANCELLATION.** Unison Credit Union reserves the right to change the rules and/or discontinue the contest at any time.
