

MATTHEW GOLDEN ITEMS – EMPOWERING TEENS AND KIDS OFFICIAL GIVEAWAY RULES

- 1. ARBITRATION AGREEMENT.** BY ENTERING OR OTHERWISE PARTICIPATING IN THE GIVEAWAY, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES. THIS CONTRACT REQUIRES YOU TO INDEMNIFY AND RELEASE ALL CLAIMS AGAINST THE GIVEAWAY ENTITIES (AS DEFINED BELOW) AND TO AGREE TO ARBITRATION WITH NO CLASS RELIEF AND A LIMITATION OF YOUR RIGHTS AND REMEDIES. ANY AND ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION WITH NO CLASS RELIEF.
- 2. ELIGIBILITY.** Unison Credit Union's **MATTHEW GOLDEN ITEM EMPOWERING TEENS AND KIDS** Giveaway is open only to Unison Credit Union Empowering Kids/Teens account members/joint accountholders who are in good standing, or Unison Credit Union account members/joint owners who are under 18 years of age with any type of account in good standing; legal residents of Wisconsin; and who have at least one account holder having either a Social Security Number or Tax Identification Number. Giveaway is subject to all applicable federal, state, local laws, and regulations. Void in all other States of the United States and U.S. Territories and wherever else prohibited by law. Employees and volunteers of Unison Credit Union ("Sponsor"), its advertising partners, their respective subsidiaries, advertising/promotion agencies, each of their respective officers, directors, and agents (collectively, the "Giveaway Entities") and their immediate families (spouse, parents, dependents, children and siblings and their respective spouses) and/or those living in the same household of such employees are not eligible to participate. Sponsor reserves the right to verify eligibility qualifications of the prize winner. NO PURCHASE, PAYMENT, OR TRANSACTIONS OF ANY KIND NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.
- 3. GIVEAWAY PERIOD.** The Giveaway begins at business opening for each location on Thursday, October 1, 2026, and ends on Saturday, October 31, 2026, at noon (the "Giveaway Entry Period"). The Sponsor's computer will be the official timekeeping device for this Giveaway. Winner(s) will be notified before Friday, November 13, 2026.
- 4. HOW TO ENTER.** There are two (2) ways to enter the Giveaway.
Purchase Entry Method. LIMITED TO ONE (1) PER DAY.
 - Each open Unison Credit Union **Empowering Kids/Teens account** in good standing will automatically receive one (1) Giveaway entry per account.
 - One (1) entry will be provided for opening a new qualifying **Empowering Kids/Teens account**.
 - One (1) entry will be provided for each qualifying cash or check* deposit totaling \$10 or more into an **Empowering Kids/Teens account** between October 1, 2026 and October 31, 2026.

- One (1) entry will be provided for each NEW enrollment in Unison Credit Union's debit card program (available to those aged 14 and up). *Replacement debit cards are not eligible for an entry.*
- *NO ENTRIES are awarded for any EFT, ACH, P2P, or electronic transactions.*

**Entries from unauthorized check use, "check kiting," or deposits made from checks that are lost, stolen, copied, fake or fraudulent are void.*

To enter without any kind of purchase/payment/transaction or obligation: To receive one (1) Giveaway entry per day, a Unison Credit Union **Empowering Kids/Teens eligible member (or parent if member is under 13)** may complete an entry form available at select Unison branches during those branch's normally posted business hours during the contest period. Sponsor is not responsible for late, lost, incomplete, illegible, incorrect, damaged, or misdirected entries, all of which will be disqualified. Entrants under age 13 must have parental permission and signature on entry form for entry to be valid. **ONLY ONE ENTRY PER DAY WILL BE ACCEPTED**, even if entries are made at different branches.

- 5. SELECTING THE WINNING ENTRY.** A random drawing will be conducted on or about the week of November 9, 2026, from all eligible entries received. Potential winners will be contacted prior to November 13, 2026. The dates of the drawing and notification may be changed by the Sponsor at any time. Odds of winning will depend on the total number of eligible entries received during the Giveaway Entry Period. Decisions of the Sponsor will be final and binding on all matters relating to the random drawing and all other matters regarding this Giveaway. Grand Prize(s) will be awarded provided a sufficient number of eligible entries are received by the Giveaway Entry Period deadline date in order to conduct the random drawing. In the event that the potential winner cannot be contacted, fails to return the consent form within the required timeframe noted above, refuses the prize, or is disqualified for any reason, Sponsor will select an alternate potential winner in a random drawing from among all remaining eligible entries. IDENTIFICATION.** Winners must show proof of identification including, but not limited to, a Social Security card, driver's license, school I.D., membership card, US Passport and/or US Birth Certificate. Participants and winners grant Unison Credit Union the right to publicize and/or broadcast their name and photo.

11. CHILDREN'S ONLINE PRIVACY PROTECTION ACT. In the event on-line data is collected about or from children under the age of 13 for the giveaway, the child's parent or guardian agrees that they have consented to this collecting or have directly submitted the information. The types of information we may collect on entrants generally include a child's first name and age. The types of information we may collect on contest winners include first name, age, videos, photographs, and voice recordings. We may display this information in our marketing or promotional efforts. We may share the information with selected third parties who provide services and products to or for credit unions and credit union members unless the parent or guardian instructs us not to do so. If we have collected personal information on a child via on-line channels, that child's parent or legal guardian may contact us at 920.766.6000 or visit us at any of our locations at any time to direct the deletion of the information or to tell us to stop any further collection or use of that information. A parent contacting us by email should include the parent's return email address and the first name of the child so that we can identify the communication.
