

SPOTTED AT THE PUMP GIVEAWAY OFFICIAL CONTEST RULES

B. To enter without any kind of purchase/payment/transaction or obligation: Snap a photo of yourself in front of a computer displaying a vehicle loan page on Unison's website: www.unisoncu.org. The Unison Auto Loan Ad must not be obscured, and must be visible in your photo.

5. **SELECTING THE WINNING ENTRY.** A random drawing will be conducted between July 21, 2025, and July 25, 2025 from all eligible entries received. Potential winner will be contacted by July 25, 2025. Odds of winning will depend on the total number of eligible entries received during the Giveaway Entry Period. Decisions of the Sponsor will be final and binding on all matters relating to the random drawing and all other matters regarding this Giveaway. In the event that the potential winner cannot be contacted, fails to return any requested items such as a name or photo release or Affidavit within the required timeframe noted above, refuses the prize, or is disqualified for any reason, Sponsor will select an alternate potential winner in a random drawing from among all remaining eligible entries.
